


SOP SINKING OF A BOREHOLE

DESCRIPTION

This document serves as the SOP and guideline for any property owner who wishes to sink a borehole. As approved by the members at the AGM held on 26 October 2016

No property owner may do so without this document being completed and agreed upon.



1. APPLICATION REQUIREMENTS


- a) The owner applying for a borehole must undertake to clean all affected neighboring properties to the satisfaction of the neighboring owner.
- b) The owner applying for a borehole must undertake to clean the road surface as well as stormwater catch pits and any open areas affected, to the satisfaction of the HOA.
- c) The applicant must obtain the signatures of adjacent property owners.
- d) The application must be accompanied by a site plan indicating the position of the planned borehole. This is to ensure that there are no immediate concerns of services being infringed upon and any services [drainage, electrical, and water] possibly being damaged.

All Tshwane regulations must be complied with:
In terms of section 39 of the National Water Act, Act 36 of 1998, the following is applicable:

- 1 Boreholes delivering less than 50 kilolitres per day are in order and no registration of the borehole is required.
- 2 Boreholes delivering between 50 and 100 kilolitres per day must be registered with the National Department of Water and Sanitation.
- 3 Boreholes delivering more than 100 kilolitres per day require a water license from the National Department of Water and Sanitation.
- 4 Water from boreholes may only be used on the property on which the borehole is drilled.
- 5 Water from boreholes may not be sold to other consumers.
- 6 The internal borehole water supply network may not be connected to the

municipal water system.

- 7 The owner is responsible for testing to ensure that the borehole water is safe for drinking purposes.
- 8 If a borehole is to be drilled in a dolomite area, a geotechnical investigation is required beforehand.
- 9 The suburbs Bronberrick and Eldoraigne are underlain by dolomite bedrock. Due to the risk of dolomite instability there, drilling boreholes in these two suburbs is prohibited.
- 10 An appropriate sign must be visible if a borehole exists on the property.
- 11 The use of borehole water is the responsibility of the owner of the property; the City of Tshwane cannot be held responsible for any health, safety, or other concerns because of the use of the water.
